Containers

Currently the Association is slow getting jugs from Bacon. Many broken promises at this point.

Pints are the main concern at this point. We currently have about 1000 cases of jugs to get the Association through the beginning of the season and to August.

Current container distribution. Lost the container dealer in Colebrook. Looking for someone else in that area.

Potential new dealer Rubin Somero of New Ipswich

Bruce Treat made the motion to have Rubin Somero a new dealer. Nick Kosko seconded.

All voted in favor of Rubin being a dealer

Discussion to make dealers pay up front over time. Dealers to pay on delivery or within 30 days

Need to do a complete physical inventory of the jugs

The new jug design No label wrapping, Red font does not work. Ben's opinion is do not touch the current version as the association has already branded that container.

Value added containers

Will become part of the dealers inventory. Candy boxes, 2 sizes 5 weeks lead time \$3491 per size. Ben to allow the association to use his box die. Ben will order the boxes 20,000 pieces as well he will order the labels for the granulated sugar containers. Total tab for both box types and stickers approx. \$9000

Ben made the motion to spend \$9000 toward value added packaging

Jeff Moore seconded the motion All were in favor

Ben promised they will be available for this season
