# **Congratulations to the 2018 Felker Winners**

This year, we had great participation in the Walter A. Felker Program. Entries came in from all over the state and all age groups. New this year, participants were not required to produce any syrup. Instead, the program asked that they to do a project on anything maple-related and submit an essay with it. The change was made to be purposely broad to allow NH youth to think outside of the box. Three cash prizes were offered: \$300 for first place, \$150 for second place, and \$50 for third place.

The containers have had a record year in sales. Starting 2018 with an already depleting supply and long lead times from the manufacturer made for a challenging year. We have worked with the manufacturer and they plan on having all our ordered containers delivered by end of year. More containers are being added to the reserve as a back up in case of future supply issues. We also have on hand NHMPA cream containers and are looking to have more NHMPA candy boxes printed.

#### Planning Committee Recap of the 2018 NAMSC/IMSI Conference

The 2018 Conference on October 26-29, 2018 in Concord, NH was the fourth time NH has hosted the NAMSC and IMSI joint annual meeting; the opportunity is available only every 16 years or so. The event required more than a year and a half of intense planning from committee members Edie and Dave Kemp, Don and Barbara Lassonde, Larry Moore, Jeff Moore, Liz Bascom, Rusty and Aggie Colby, Sue and Brian Folsom, Roy and Mary Ellen Hutchinson and Dale Smith.

This year's program booklet was dedicated to Hank Peterson. A few extra booklets will be available for free at the Winter NHMPA meeting. They contain information on the IMSI and NAMSC and are a great keepsake.

The conference was attended by more than 240 people including maple producers, scientists, equipment suppliers, and people interested in the maple industry. All of the US maple producing states were represented as well as all maple producing provinces in Canada. There were meetings to attend so all could understand what the two organizations are doing for the maple world.

Technical sessions included discussion topics from the UVM Proctor Research Center, updates on current Asian Longhorn beetle infestations, strategies to mitigate climate change on sap production, maple forest health after timber harvesting, three generations of an old-time sugarhouse, a deep dive into the food safety and modernization act and how it impacts sugar makers, agritourism, maple finance, and business viability.

Of special note was a maple artifact room which included items from the Charlie Stewart collection, a spile collection from Mike Girard, a syrup tin collection from Tom Lacromb, and an original gas-powered tapper from the Moore's. It was an opportunity for maple enthusiasts to see items they would not see elsewhere.

# The Annual IMSI/NAMSC Meetings

The joint-annual meeting of the International Maple Syrup Institute (IMSI) and the North American Maple Syrup Council (NAMSC) was held October 26th-29th in Concord, NH. The NHMPA delegate representative was David Kemp.



This is a short synopsis of what has transpired this past year. The ISMI has already posted a report on their website under Resources, and it is anticipated that the Maple Digest will have the NAMSC report.

# **IMSI** Highlights

Growth in maple syrup production capacity in the U.S. is estimated at one million taps. Maple equipment vendors reported that new maple equipment bookings are extending into 2019. Tariffs imposed by the U.S. on aluminum and steel are putting some upward pressure on prices of maple equipment containing these materials.

Maple packers report that the demand for maple syrup and other real maple products remains very good and is gradually increasing both in North America and overseas. Use of real maple syrup in a variety of food products is growing and is noticeable in retail outlets both in the United States and Canada. Profit margins, however, are thin in some circumstance, and the marketplace is very competitive. Prices for packaging are increasing significantly.

Added Sugar: The FDA will be delivering revised draft guidance early in 2019 that would remove the Added Sugar line item requirement from some single-ingredient products such as maple syrup and honey.

The United States Department of Agriculture is currently embarking on a review of Dietary Guidelines for Food Products. Since this review and new dietary guidelines could ultimately have significant implications for the maple syrup industry, the IMSI has been monitoring arrangements for the review closely.

Maple Grading Schools and Quality Assurance Training: The IMSI-sponsored grading school delivered a very successful school in Keene, NH in October 2018 prior to the conference. A school is planned in conjunction with the NAMSC-IMSI Annual Conference in Duluth, MI in October 2019.

New committees and initiatives: IMSI Commission or Study Group has been greenlit to review the IMSI's Mandate and make recommendations for future investments. A U.S. Maple Industry Alliance comprised of state maple association representatives has been put in place to help assist the IMSI in monitoring and addressing issues which may emerge from time to time in the United States. IMSI Social Media Initiative continues to make progress but has had a recent change in the chair of the team.

#### Reminder



Each year, NHAITC hosts its Agricultural Literacy Program. The selected book is read by volunteers in elementary school classrooms around the state. This year's book, *Maple Syrup from the Sugarhouse*, follows the tale of Kelsey as she and her family and friends collect sap to turn into syrup.

### **Maple Equipment Grants**

For the second year in a row, NHAITC is taking applications for its Maple Equipment Grant program. The program helps reduce the financial burden for K12 educators who want to do hands-on maple sugaring education in their classrooms. Recipients are required enter the Tucker Mountain Challenge competition. The deadline to apply was Dec.15th.
